NOTICE: Humboldt Bay Municipal Water District is requiring that all boats be inspected for Quagga and Zebra mussels before launching. Please get your boat inspected prior to the tournament. For more information, call RLCSD @ (707) 574-6332.

This is a catch and release tournament, five fish per team, 13” mouth open minimum length, measured on a WIL-E-GO belly board. There will be a 1 lb. penalty for each short fish and a .125 lb. penalty for each dead fish. Life jackets must be worn when big motor is running. Boats must have an aerated live well. No boat may fish within 100 feet of another boat. Blast-off numbers will be drawn. Boats late checking in for weigh-in will be disqualified. Entry fee will not be refunded unless tournament is cancelled. Live well checks will be made in the Marina parking lot prior to launching. Artificial lures only during this tournament. Anyone that displays poor sportsmanship or violates boating or CA Fish and Wildlife laws will be disqualified. No alcohol or drugs allowed. DECISIONS BY WEIGH-IN OFFICIALS WILL BE FINAL.

Check-in will be at the marina parking lot on Friday, May 3rd from 5:00 PM to 7:00 PM and Saturday morning beginning at 4:45 AM. There will be no off-limits for pre-fishing. Blast-off will be at 6:00 AM. Weigh-in will be at 3:00 PM and 3:15 PM.
